### DEATH OF MRS. LLWYD

On Thursday, the 4th May, at the home of her son-in-law, Mr. Mackie Kinton, at Huntsville, there passed to her rest one who has been most intimately connected with the life of that town for the past thirty-eight years, Mrs. Emma Llwyd, widow of the first Archdeacon of Algoma, the Rev. Thomas Llwyd. Her unassuming, gentle character, both as the mother of a large family of sons and daughters, and as the faithful and loyal wife of a most earnest and hard-working clergyman, furnished her with countless opportunities to give evidence of the many virtues which she possessed to a notable degree.


Mrs. Llwyd was born in England in 1838, and accompanied her husband and family to Canada in the spring of 1874, dwelling for a few months at Galt, Ontario, and from thence coming to Muskoka, where, in the arduous life on a bush farm, were undergone many of the difficulties and experiences of the early pioneer life of this country. After two years her husband was ordained and appointed incumbent of Gravenhurst by the late Bishop Fauquier, and the next eight years were devoted to the duties of an earnest co-worker with her husband in that town. But in 1884 a call came from the new and growing village of Huntsville, and from that time Huntsville has always been the home of some member of the Llwyd family.

The funeral took place in All Saints' Cemetery, Huntsville, after a most impressive service in the church, where the Rector, the Rev. P. J. K. Law spoke most feelingly of the character of the departed. Her husband predeceased her on the 18th July, 1903, in his sixty-sixth year, and she is survived by five sons and three daughters: the Very Rev. J. P. Derwent Llwyd, D.D., Dean of Nova Scotia; Mr. T. D. D. Llwyd, Toronto; Mrs. Mackie Kinton, Huntsville; Mrs. W. B. Magnan, Denver, Colorado; the Rev. A. R. Llwyd, Bishop's Commissary, Port au Prince, Haiti, W.I.; the Rev. H. J. Llwyd, Muskegee, Oklahoma; Mrs. E. J. Ecclestone, Huntsville, and Mr. H. B. D. Llwyd, Toronto. One son, Charlewood, for many years the beloved blind organist of All Saints' Church, died some years ago.

## "GOD SO LOVED"

A Church of England missionary magazine makes the following spirited comment upon "interest" in the Church's missionary work:

"Please don't be 'interested' in foreign missions! That is such a painful expression. You could be interested in a book, or in a piece of needle-work, but not in missionary work. The word is altogether unsuitable. Suppose God had been merely 'interested' in us."

According to what is probably the most familiar of all precious passages in the New Testament, our redemption was wrought because God **so loved us** that He gave to the uttermost for our salvation. The tragedy of missions is that some Christians are only interested and many others are not interested at all. If we were on fire for God, if we loved souls, "interest" in the Church's mission would indeed be a painful and feeble expression. Fancy the lot of a child whose mother was only interested in it; picture the state of a parish whose rector was animated by anything less than zeal for the Kingdom of God. And pity the communicant to whom the Church's mission is not supreme, whose giving is not measured by love to the point of self-sacrifice.

## DIOCESAN NEWS

### ST. PETER'S MEMORIAL CHURCH OPENED

The opening of the new St. Peter's Church, Sault Ste. Marie, was to have taken place on the 23rd February, and the Archbishop, who was in the midst of a visitation in the Parry Sound district, came back especially for the occasion. But a very severe snow storm, lasting throughout the night of the 22nd and the following day, filled the roads to such an extent that it was impossible to hold the service:

The delayed ceremony took place on the evening of Thursday, March 9th, and was attended by a congregation which taxed the capacity of the building. The service consisted of Choral Evensong, with a sermon by the Archbishop. The Rev. P. F. Bull, the Rev. B. P. Fuller, the Rev. W. H. Hunter, the Rev. E. H. C. Stephenson, and the Rev. F. W. Colloton were present, and assisted the Ven. Archdeacon Gillmor in the service.

Several members of St. John's Choir united with the regular Choir of St. Peter's, and a large number of friends from neighboring parishes joined with St. Peter's congregation on this happy occasion.

The building is a very attractive one indeed. The interior finish is wood throughout. All the detail work shows the utmost care in finishing, and reflects the greatest credit on the builder, Mr. Ramey.

Especially worthy of mention are the beautiful east window, formerly in the Church at Hurstpierpoint, Sussex, and the fine painting of the Crucifixion, for both of which, as well as for much financial assistance, the church is indebted to friends in England.

### CONSECRATION OF ST. SAVIOUR'S, DESBARATS

Arrangements had been made for the Consecration of the church at Desbarats to take place on Sunday, the 22nd January, but a terrific blizzard, which raged throughout the preceding night, buried the roads under deep snow drifts, and rendered approach to the church impossible. So the Archbishop had to return home without performing the ceremony.

But a fortnight later, on February 5th, at 11 a.m., the Church of the Holy Saviour was solemnly "set apart from all profane and common uses" and dedicated to the worship of Almighty God. The service was most impressive, and there was a large attendance.

In the after-noon a Confirmation was held. The Archbishop's addresses on both occasions were listened to with rapt attention.

Great credit is due to the congregation of this church, which, under the devoted leadership of the incumbent of the mission of Bruce Mines, the Rev. P. B. de Lom, has not only paid off a long standing debt on the church, but also greatly improved the interior of the building. Mr. E. R. Leslie Holland, B.A., the organist, is a tireless worker in the interests of the mission. He has recently been granted a lay reader's license, and is doing excellent work.


The services on Easter Day at St. James' Church were well attended, and were a source of much encouragement and spiritual refreshment. The Rev. Canon Allman, B.Sc., the Rector, officiated at four services, and the choir gave an excellent lead to the inspiring Easter hymns. The number of communicants was large and the offerings generous.

On Easter Monday the annual vestry meeting was held, and well attended. Dr. C. D. Parfitt, the Rector's Warden, presented the financial statement, which showed considerable advance over the previous year, although the accounts had only broken even. Gratifying reports were also read from the Woman's Auxiliary, the Sunday School, the Junior Auxiliary, and the Parish Hall Committee. Dr. Parfitt and Mr. Robert Fielding were re-appointed churchwardens, and cordial votes of thanks were tendered them, and also the various organizations and officers, for their services in the cause of the Church. A unanimous vote of thanks was also tendered the Rector, to which he replied briefly; and with the Benediction ended a very harmonious and successful meeting.

## IN MEMORIAM



REV. CANON FROST

In the death of Canon Frederick Frost on the 24th of April, 1922, we have lost our senior missionary in the Diocese of Algoma.

He was born in England on January 26th, 1851, and came to Canada from Ware, Hertfordshire, in 1872. He commenced his great and long work as lay missionary with the Indians at Garden River in October of that year. He received Bishop Fauquier's license the following year, immediately after the consecration of the first Bishop of this Diocese. In May, 1877, he changed his field of work to Sheguiandah, on the Manitoulin Island, with

Indian congregations at that place, and also at Spanish River, Birch Island, Whitefish River, Killarney, Collins Inlet and French River; and having English congregations as well in that widely extended field. He visited on different occasions and taught the Indians on Lake Nipigon and the north shore of Lake Superior.

He was ordained by Bishop Sullivan, Deacon June 3rd, 1883, and Priest, October 4th, 1885, at St. Luke's, Sault Ste. Marie. He worked in the Sheguandah field until July, 1897, when he returned to Garden River, where he lived until May, 1907. He then gave up Indian work, and took charge of the beautiful mission of Rosseau, with all English-speaking people, on the Muskoka Lakes, where he continued until March, 1918, when his health broke down, and he retired from active service.

He was made Honorary Canon by Bishop (now Archbishop) Thorneloe in 1906. He was the author of a most interesting book, "Sketches of Indian Life," showing very graphically the lives and habits of the Indians among whom he laboured. He was the editor of the Ojibway Hymn Book (S.P.C.K.).

Canon Frost was twice married. Of the first family (three sons and two daughters) one son is living in British Columbia, and one daughter, Mrs. Allen, resides in Sault Ste. Marie. Of the second family there survive the widow, a son and a daughter who live together at Rosseau, and one daughter, the younger, is married and settled there.

Canon Frost lived nearly fifty years in the Diocese of Algoma, and of that period thirty-five years were spent among the Indians. With him it was never a matter of stipend or position, but entirely the saving and keeping of precious souls. His work among the Ojibway Indians was of the best, the truest, and his knowledge of their language was perfect, so that he could send home into their hearts the glorious truths of Christ. Indeed his knowledge of Ojibway was so thorough that he certainly thought in that language, and expressed himself, and often with considerable humour, in the quaint manner of the Indian.

He lies buried in the secluded little cemetery near Rosseau, and his grave is surrounded by the thick foliage of the maples; and stretching away for miles lies the wonderful beauty of the Muskoka lakes. Our dear brother has been called home, and we shall meet him again amid beauty far, far greater.
