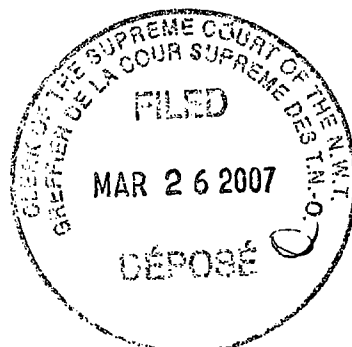

proceedings is hereby so amended, including the addition of certain former third parties or parties to the Catholic Entities Agreement as party defendants.


