Council Meetings From The First Two Minute Books Of The Township Of Cockburn Island 1881 to 1929

March 21 1881

The first meeting of Council met pursant of the notice of Judge McCrea dated the 28th day of February 1881 at the house of S.F.Tolsma on Monday the 21st day of March 1881, finding that occupied it was moved and sec. that we adjourn to the Indian Land Office of Cockburn Island.

Mr.W.Harper accepted (clerk) for the present year, at the sum of five dollars \$5.00 as per tender.

Mason Hill made application for a bonus of \$1,000.00 one thousand dollars to aid in building a saw and grist mill on the town plot on Cockburn Island,

April 4 1881

Tenders for the office of Assessor were opened and read, moved by J. Street sec. by W.L.Pateman that the tender of Thomas Stephenson for the sum of \$8.00 eight dollars be accepted.

Moved by Joshua Reid sec. by W.L.Pateman that the Council accept the offer of Mason Hill to grant a loan of \$50.00 fifty dollars, for six months at 6 percent.

April 1881

Moved by M.Clark sec. by W.L.Pateman that B.W.Ross be appointed Treasurer.

Moved by M.Clark by J.Reid that the present Council of Cockburn Island receive for the present year one dollar each, each sitting of the Council.

May 23 1881

Moved by J.Reid sec. by W.L.Pateman that J.M.Hamilton Crown Attorney be paid \$5.16 for letter of advice and postage on books sent by mail.

Pathmasters

Joshua Reid be appointed Pathmaster on the 10th side road between 8th and 9th con.

Thomas Reid 10th side road between 10th and 11th con.

Malcolm Clark 15th side road from 7th con. north to the 12th con. and also from lots 14 on the 7th and 8th con. west to lot 20.

W.L.Pateman on the street between lots 12 and 13 between the 10th and 12th con.

John Street 11th and 12th Con. between the town plot and lot 20.

August 10 1881

Court of Revision

The Council met in the house of the Indian Land Agent.

It is moved by W.L.Pateman sec. by John Street that the assessment of the Manitoulin Railway, Telegraph Timber Supply Company be lowered from \$25,000.00 to M.S.Vancoughnets valuation of \$15,000.00.

It was moved by John Street sec. by W.L.Pateman that on account of the non-appearance of J.A.H.Campbell of the Company of Campbell, Pratt and Rose, before the Court of Revision their assessment stand as entered by the Assessor.

Moved that the assessment of W.Geo.Richards remain the same.

November 9 1881

It was moved by W.L.Pateman sec. by Joshua Reid that the conditional offer of the superintendant General at Ottawa offering this Municipality \$500.00 for the opening up of the leading lines on conditions that said Municipality make the roads and expend \$1,000.00 on the same, be submitted to the voice of people for them to vote Yea or Nay on the 5th day of December next at 10 o'clock A M.

Christopher Nixon be allowed to perform 4 days statue labor on the 5th and 6th Con.

Wm.Madill be appointed Constable.

George Burns - Collector. Donald McLain Brown and Thomas Stephenson ratepayers and residents be accepted as Bondsmen.

January 16 1882

George Benjamin (paid \$2.00) and Albert E. Street (paid \$1.00) be appointed as Auditor for the year ending December 31 1881.

A petition was presented to the Council by John Connor and thirteen others praying that a school section be formed on the north eastern part of the township, comprising concessions 9, 10, 11, 12, 13, and 14 from lots 1 to 20 on said Con. respectively.

A.E.Street to receive \$25.00 as salary for the office of Clerk.

B.W.Ross \$10.00 as Treasurer.

March 13 1882

Moved and sec. that the Reeve be authorized by Council to go and call on R.A.Lyons Esq. M.P.P. Michaels Bay, Manitoulin, and obtain an introductory letter from him and wait upon the Hon. McMowat The Commissioner of Public Works also to explain and represent the wants and circumstances of the settlers of Cockburn Island in order if possible to obtain a grant from the Ontario Government to be expended in opening up the leading lines on said Island, and that the Reeve draw on the Treasurer for the sum of \$40.00 forty dollars to defray expensed while employed on said business.

Petition of Gilbert McWhirler and others (roads).

August 28 1882

Moved and sec. that an order be issued on the Treasurer for the sum of \$9.50 price of handcuffs and also that the Reeve issue an order for express charges 65¢ for the said handcuffs.

Moved and sec. that the Clerk write to the License Commissioner that the Council have passed a by-law prohibiting the sale of intoxicating liquors and issuing of licenses therefor within the Municipality of Cockburn Island.

August 28 1882

Paid by order to Wm.J.Lotten for erecting school house in school section No. 1 the sum of \$170.00.

November 10 1883

Municipal rate 1 cent on the dollar.

January 16 1884

Indian Agent B.W.Ross.

Council receives grant from Indian Dept. for roads, and Province of Ont.

January 16 1884

Moved by J.Street sec. by D.Brown that whereas the land on Cockburn Island belongs exclusively to the Honorable Indian Department, the sale of which would be greatly facilitated by the erection of a substantial wharf at Tolsmaville. As at present on account of the old wharf having been damaged to such an extent by ice and storms that it is entirely useless, that the boats cannot call thereat and the residents on the Island depend in a great measure on the landing of their supplies for substence. We would most respectfully ask that the Department would build a wharf and this Council would recommend that their successors in office do pay an annual rent for the same, as under the present circumstances we do not get our mail regularly nor can the travelling public either reach the Island or depart therefrom without great disadvantage and delay.

To let a contract for ditching on 10th side road. Extension of one month for erection of saw, shingle and grist mills. September 27 1884

By-law be drawn up granting to Thomas Stephenson and John Connor the right of way for ten years of the beach road in front of lots 25, 26, 27, 28, 29 and 30 in the village of Tolsmaville for mill purposes. (rejected November 20 1884).

January 21 1885

That George Burns be given six dollars \$6.00 for rent of his house, Tolsmaville for Council purposes for one year.

Auditors to receive \$1.50 each (two men) for auditing last years accounts.

By-law No.3 prohibiting the sale of intoxicating liquors and the granting of licenses therefor repealed. It was moved by W.Johnston that the said by-law No.3 be repealed sec. by T.Reid. D.Brown moved an amendment sec. by E.Wiggins that by-law remain as is. The amendment carried by a vote of 3 for and 2 against. November 20 1885

That this Council appoint W.L.Pateman to find a suitable place for a cemetery.

January 4 1886

A petition was received from B.W.Ross Esq. and several other ratepayers praying for to have the bridge over the ditch on D St. Tolsmaville repaired, also the crossing west of J.Connors on D St. repaired, the logs are loose. W.L.Pateman \$13.00 for services as Reeve and one day service for finding suitable burying grounds.

In the matter of a claim of W.B.Ross against this Municipality of Cockburn Island for an alleged seizure of a mare by the Tax Collector last fall who seized a mare in the possession of one James Robb for said J.Robb taxes.

It was moved by E.Wiggins sec. by John Reid that this Municipality defends the case in court, entered by W.Ross for \$30.00 damages for alleged illegal seizure of a mare last fall by their Collector Thos.Stephenson. Amendment. It is moved an amendment by Joshua Reid that the Council pays W.Ross the \$30.00 and settle the matter. No Seconder. The first motion by E.Wiggins that the Council defend the case being put is carried. John Street with the mover and sec. - for. The Reeve and John Reid - against.

April 5 1888

Moved by John Reid sec. by E.Wiggins that the Clerk attend the Court, also the Collector T.Stephenson on behalf of the Municipality to give evidence as to the fact connected with the said seizure of a mare in possession of James Robb. Carried.

April 5

Moved by J.Street sec. by John Reid that an order be issued to the Clerk for the amount of \$25.00 to defray the expenses of the Clerk and Collector to attend the Court at Hilton or wherever held.

Preistman, J.Groyer workmen of W.Ross.

June 6 1888

That the Council of this Municipality Memoralize the Minister of Public Works and petition the government to have the new dock built at the foot of T Street instead of at the proposed site at the west side of the Town plot.

July 7 1888

In regard to building the approach to the wharf, the contractor Robert Reid in consideration of the Municipality building the first fifty feet from the store which the Council proposes to do with the statue labour of the village, agrees to build the remaining 75 feet for the sum of \$500 and wait 6 months and at the end of that time to accept as much as this Municipality can pay and accept debentures on the Municipality to run at legal interest or to accept cash. Accepted.

Special meeting called to consider means cost price of machinery and bylaw for raising money by debentures to meet payment of a saw and grist mill for the use of the Municipality.

That the Clerk write to Messrs. Beckett and Company of Hamilton and find the cost of small grist mill offered by them in connection with saw mill machinery offered by them, also as to terms of payment that they will accept debentures on the Municipality of amounts so arranged as to pay the amount in five years.

July 16 1889

Appoint a committee for site of mill.

August 24 1889

Site picked lots 15,16,17,18,19 and 20 on Water Street.

September 14 1889

By-law 25 read for purchasing machinery for and establishing a saw and grist mill and be advertised.

October 14 1889

Special meeting of Council held to take into consideration action to be taken to meet and defend case entered against this Municipality for alleged illegality in proposed by-law No.25 by Messrs. Hitchock and Foster.

October 14 1889 That the Clerk of the Municipality A.Monck be sent to defend the case entered in High Court of Justice at Owen Sound by Messrs. Hitchcock and Foster through their Agent George Avis, said A.Monck to have full power to employ a solicitor in said defence. \$50.00 for expenses. (Hitchcock and Foster we believe have a store on Cockburn. W.C.Foster and G.Avis were auditors for 1888.) November 2 1889 Chief Justice Galt at Toronto determined by-law 25 was illegal. Moberly and Gamons Solicitors bill for defending case \$30.39. Clerk expenses \$38.60. Residents 1890 George Richards, Bennett Edwards, Benjamin Madill, J.Weatheralt, Francis Forbes, Robert McKenney, Thomas Haight, Angus McLeod, Arch MCaig. In the interim W.C.Foster Councillor whose seat has been contested by Thomas F.Reid and adjourned from time to time has been unseated by judgement of the High Court.

\$60.00 for crossway and covering the same with earth or gravel on the con. line between the 7th and 8th con. lots 21 and 22.

That the amount of thirty dollar be awarded and expended on the side line between lots 10 and 11 in the term plot of Tomalsmaville Community at the 2nd hill from the Bay at Robbs Castle. The ditch to be cleaned out and the road gravelled. The same to be brought from the said hill and spread on the road towards the Bay to be by auction on Monday 29, instant on the ground at ten o'clock.

That this council purchase the two lots land 2 H.St.S. selected and used as a cemetery in this Municipality and that an order be issued of \$5.00. to pay the first instalment on them to A.Monck Clerk. Order issued \$5.00. January 15 1891

That B.W.Ross has an order on the Treasurer to the amount of \$30.00 as part liquidation of expenses to Ottawa in 1888 to apply to the Government for the removal of dock site.

Constable B.S.Rombough to receive \$5.00 reward for every case he can infraction of the law he can bring and gain a conviction for such infractions of the Liquor Law License, this in excess of his Constable fees in stamping out the illegal liquor traffic.

\$20.00 to open up con. line between 9th and 10th con. east across of lot 15 and as much further as may be 12' wide. May 2 1891.

May 2 1891

\$50.00 grubbing and crosswaying between lots 20 and 21 on 13 con. 12'
wide.

April 13 1892 B.W.Ross being in occupation of lot 6 south J. Street. May 14 1892 Circular of the Algoma Colonization co.read (for advertising Algoma).
