- M. Pitcher- Suggests Board of Governors instead of Senate
- A. Pitts- Suggests working with students on issue
- J. Tetreault- Suggests racism training during welcome week
- P. Quesnele- Suggests finding a speaker in the speakers' bureau
- A. Pitts- talked to CFS, limited campaign material, we have it already

- M. Pitcher- Reminds council to check e-mail every day
- A. Dukes- Concerned about current meeting times
- J. Tetreault- Suggests holding executive meetings to cut down on regular meeting length

Senate Committees

- M. Pitcher- Encourages everyone to go to their Senate Committees
- J. Tetreault- Reminded council about Senate trying to remove AUSU representation on Senate committees last year due to lack of participation.

Semi Formal
