- Charter Advisory Committee explanation which Rob Skeggs sits on
- Presentations to explain the transition to independence
- Will go internal and then external to the city and other groups in our community
- Presentation (handed out to the union)
- Ouestion Period:
 - o General Questions and Concerns -
 - How will you increase numbers to 3000 students? Independence will assist this, more recognition, as we grow we get more of what students need such as 4 year programs.
 - Are you saying that once we are independent we will have more indigenous faculty but what about now? Are we not qualified enough as we are? Resolved to put more attention to about 15 years ago. There haven't been many indigenous people with Ph.D.'s in the past. It has been a building process to get to where we are going. The current hiring round has one faculty member that is being considered.
 - O Is there no active recruitment? Is there a strategy and if so how is it being implemented? Advertising in the areas in which there are faculty members the school would like to apply. It is not possible to hire who they want to hire due to the collective hiring agreement.
 - Will there be problems associated with the sister student of Shingwauk University and the separation between Laurentian and Algoma?
 - Students have a major lack of clarity and they are experiencing insecurity in terms of the independence of Algoma University.

- For the international students what does the recruitment strategy have to do with the long term? Is it just to get independence and it will be forgotten afterwards?
- What is the timeline? The school is currently about halfway into the plan and in 2008 there will be a formal request and in 2009 success will be relayed to the administration. The government may decide to move much more quickly or much more slowly. The school itself is moving quickly on their timeline.

Hockey Team:

Proud Algoma:

- Rebecca and Sarah drafted and presented a budget as circulated.

Fair Trade Algoma:

- Amie Harnish: discussed the budget and explained that the club is about the unethical actions of Algoma University.
- High estimation with regards to costs fair trade is more expensive. Costs may include lawyers' fees once contracts have been attained.
- Fair trade definition: farmers are paid fairly due to price floor, along with community development.
- No negative feedback yet little support.

This way we can see if the process, as it exists, is working properly. As well, Tom Broxham has sent information regarding the previous election mishaps.
- *Rob Mallette recommends hiring Justin Tetreault.

Table the motion to hire Justin Tetreault as the CRO for the upcoming election.

*Rob Skeggs and Carson suggest posting the position because we have to follow procedure but window has to be small.

Be it resolved that Justin Tetreault be hired as the CRO for the 2007 AUSU elections. Call to question: all in favour 0, against – motion not carried.

Be it resolved that we post the CRO position internally and close the nominations at 5:00 pm on Tuesday, March 6, 2007. All in favour – motion passed.

- 3) SASA Budget (/)
- *SASA provided us with a copy of their budget.
- * In the past a block of \$15 000 was given and without Josh being here we should push this to next week's agenda.
- 4) Hockey Team Funds (Rob/Mike) all in favour 2, opposed -7, abstentions 1 motion not passed.
- * Rob S.- Perfect example of AUSU being a cash cow. If each member was to put in \$50 then they would have the cost covered. As well, their excuse of not having the means to collect all the money although they meet regularly.

- *Carson they do have alternative sponsors and AUSU has received no recognition. They are paying next to nothing in comparison to other teams. As well, there has been disrespect directed towards AUSU and they are ungrateful.
- *Paul Skeggs Brody's sponsors numbers of teams and it wasn't an effort of the team. In the future we should request our logo be on their shirts or on anything else if that is what we want.
- *Kirstan we did outline that they could return for funding should they require it.
- * Rob M they have not gone through the correct avenues to get funds and they have not solicited their team members accordingly.

Be it resolved that AUSU donates \$1000 to the Algoma University Hockey Team.

- * \$725 for the events being held this school year.

Be it resolved that AUSU approve \$725 for Proud Algoma with the exclusion of the rest of the budget (including promotional cost and transportation). The other aspects of the budget will be up to the consideration of next year's board.
