Agenda Item 4: Algoma University Hockey Team

- The team is returning before the board with a new funding proposal with specific fundraising goals. In the spirit of this, they had 2000 tickets printed for a raffle. For the next several days, members of the hockey club will be selling candy canes for \$2.00 a piece or 3 for \$5.00, in which a ticket would be included. The draw date is December 16, 2007. They are asking to pay for the prizes and printing.
- Their overall target numbers are included in the first proposal in possession of the board, but this is a means to an end. It is the clubs hope to become a fully funded varsity team.
- When asked about sponsorships, the board was informed that the University donated \$1000 to the team, and there is a per diem/per player agreement with Wingnuts. In regards to funding from the previous year and bank accounts, an account is open at the Royal Bank, but there is a small sum of money in the account, which is frozen for inactivity.
- The hockey club asked if they could come back with other fundraising proposals. They could return to ask for more money, but the board will take into consideration any funds made from this and any further fundraiser

Agenda Item 5: Chris Shoust

- The fire arts program is continuously growing and are now having 3 exhibitions per year. Now, there should be some way to document the artworks in catalogues for future students in the department to see past examples of works that were produced.
- The fine arts department has been approached about this project, and they think it is a great student imitative, but they don't want any involvement. As indicated in the budget proposal, the costs have been brought to a minimal as much as possible. But, as a board, we need to know exact numbers, rather then ranges. The board inquired if the catalogues would be sold to students, but there is some hesitation. The don't want to bring in more copies then what could be sold.
- The catalogue would include both black and white and colour photographs. The minimum number that can be printed is 20. The cost per book to print ranges from\$14.15 for 20 books and \$13.55 for 50 books. There could be a possibility of pre-ordering, but since people don't know what to expect, then they may not order. But, Jessica suggests that a prototype be printed as a

sample for people to see. Given that this is a non-profit idea, they are looking to negotiate on the prices.

• Jessica will talk to the chair of the Humanities department about possible input, but the AUSU board is interested in the idea and wants to support it.

Agenda Item 6: Club Packages

- The policy needs to be adopted by the board as AUSU policy in order to pursue club compliance in the matter. By adopting it, it would act as a matter of continuance from year to year.
- The only major issue was regarding the withdrawal form. There is some confusion as to its intended purpose. It was thought to be a form for clubs to voluntarily withdrawn themselves from the registry. But in fact, this is for AUSU de-registration of a club, and will act as a notice of justification which will be put on file.
- It was asked if there should be financial guidelines to be put into the club package, which specifies that AUSU is only willing to help with fundraising efforts. But, there will be some exceptions to the rule. As a board, we will approach each case from a conscientious standpoint and view it on its merits.
- Our job as a board is to spend money, but in a fiscally responsible manner.
