- Play 40 games of Hockey and practice ice times
- Play twice a week and a really big commitment
- Ash- asking for money to do the tryouts- 378.63 for tryouts will the tryout fee
- Ash- asking for 200.00 from players
- Deciding to bring the roster down to 17 players
- Ash- Percentage will be Non Algoma U students- 3 max
- Ash- Do not want to fund $50 \%$ of non Algoma $U$ students
- Ash- if the Algoma U student fee is $\$ 200.00$ and they have a higher fee for non students
- Giordano- would send a roster list to use
- Josh- Play in the mens league?
- Yes they do
- Jason- love clubs- proposed budget is about half of our budget that goes towards everything
- Matt- Clubs budget overall which includes SASA if we approve the SASA and hockey budget
- Mike- the problem is that the club is not the same as a regular club- it is more of a sport
- Giordano- would come with a fundraiser proposal for each one
- Matt- would the extra money come back to AUSU
- Mike- only fair to be left for the hockey team last year or back to AUSU
- Josh- sounds like a Sault Ste. Marie club rather than a Club Group
- No other clubs stated that you have to pay for ice time
- Ash- there are different clubs- clubs and associations fall under the same policy along with SASA
- Jason- theoretically if you got half of the budget what would you do to cover the rest?
- Giordano - have meetings with Celia Ross and Tom
- Mike- who do we speak to having the Hockey Club to change to an Association
- Mike- is there anything that the union can do to get the hockey team funded
- Ash- need to approach the union and they community to represent all of Algoma U
- Should get together with the GLC and with administration
- Jason- we should be giving some money
- We should be a partner with the hockey club
- Take this as a union issue for funding and with administration
- Ash- might consider to ask for a referendum question to ask for ancillary fee of $\$ 1.00$ for each student
