

# Proud Algoma Funding Request – Queer Voices of the North Film Festival January 18, 2009

The Queer Voices of the North Film Festival Coordinating Committee was founded in 2005 by a network of invested partners for the primary interest of developing and delivering educational and informational material to the queer and queer-friendly audiences of Sault Ste. Marie. The committee members recognized a gap in the available information and positive space where insightful and thought provoking queer topics are introduced and discussed. Seeking to fill that void, the Committee brings intriguing and refreshing media to Sault Ste. Marie and develops thoughtful local dialogue on questions of sexuality, culture, and society.

#### Benefit for Students and Algoma University

Providing a queer-positive space for the discussion of issues identified above, Queer Voices has been identified by both students and faculty as an important event to attend. In addition to providing this space and content, films from the festival will be donated to the Algoma University library on behalf of Proud Algoma. This has been done in the past and has proven benefit as these films have been screened in a variety of classrooms. We also plan to film the panel discussion following the Queer Voices screenings – as was done in a past Proud Algoma event – and donate a copy of this to the library.

# JANUARY 8, 2009 STUDENT FEES FISCAL 2009-2010

#### Issue

Board of Directors' approval of an increase in student fees for fiscal 2009-2010, as outlined below, is being requested.

#### Background

Student fees are comprised of two amounts, tuition fees and compulsory ancillary fees. Tuition fees for domestic students are regulated through the Ministry, but tuition fees for international students are at the discretion of each university

## Undergraduate domestic tuition fee background

The Ministry of Training, Colleges and Universities (MTCU) ended a two-year tuition freeze and announced a new tuition framework in March 2006. (It is important to note that the government gave the universities compensatory grants for the two years of tuition freeze – these grants were discontinued when the tuition freeze was lifted.) The 2006 framework approved a maximum average annual tuition fee increase of 5%, with 4.5% for first year undergraduate Arts & Science students and 4% for upper-year students undergraduate Arts & Science students allowable each year for four years starting 2006-07. This tuition agreement expires after 2009-10.

Algoma University ("'AU") has raised tuition fees by a flat 4% each year of this agreement. Based on *MacLean's Magazine*, *November 24*, 2008 (see chart at end of this report), for the academic year 08-09 of the 19 Ontario universities, AU has the:

- 3<sup>rd</sup> lowest tuition fees, at \$4,666 98.7% of the Ontario average;
- 3<sup>rd</sup> highest ancillary fees, at \$951 123% of the Ontario average; and
- 4<sup>th</sup> highest total fees, at \$5,617 102% of the Ontario average.

Fiscal year 2009-2010 will be the last opportunity to raise tuition fees under the current MTCU directive. All Ontario universities who have made multi-year tuition fee decisions during this period have either chosen the maximum increase possible or the 4% flat increase. It is probable that all remaining Ontario universities will opt for at least the 4% increase for next fiscal. Tuition fees are a vital part of university revenue, not least because MTCU has not increased basic operating grants since 2005-06. Increasingly, tuition revenue is what permits universities to maintain quality access to professors, learning resources and equipment.

Tuition fees were last discussed at the February 2008 Board meeting whereby it was agreed to a one-year increase of 4%.

Our formal communications with the Ministry have indicated that there will be no year-end funding this fiscal. Since 2006-07, it has been year-end funding that has allowed universities to balance budgets given the lack of increase in operating funding. Given that AU is expecting to run a deficit of at least \$500,000 in the current fiscal year, and that transition funding received this fiscal was \$500,000 less than expected, administration believes a tuition fee increase is required.

If we increase tuition fees less than the maximum permitted in any one year, the Ministry does not allow us to "catch up" the increase in subsequent years. Also, expectations are that additional funding will not be forthcoming from the Ministry if we have not taken advantage of raising funds where permitted – which would be the tuition fee increase route.

The increased tuition fees will play an important role in maintaining academic quality at Algoma as we move into a period of extreme fiscal restraint. It is anticipated that cuts will be required across the board next year to maintain a functional university budget. It is the university's intention to have these cuts affect the student experience as little as possible. Maintaining the current faculty complement, an acceptable range of course selection, adequate student services, library ordering and electronic resources, etc., depends on revenue keeping pace with costs. This same scenario is playing out in all of the Ontario universities.

#### Compulsory Ancillary Fee Background

AU's ancillary fees are at the 'high end of the pack'. This is a result of:

- Higher heath insurance costs, as AU covers a very small group of students.
- A component within the ancillary fees that includes repayment of the student centre part of the ICT building.
- Higher costs associated with AU athletics programs and facilities as the costs are spread over a relatively small student body.

Exercising restraint in the ancillary fees, i.e. a 0% increase, will bring AU's fees down to the 'middle of the pack'. This does make it harder for ancillaries such as the George Leach Centre to break even, but we will address this difficulty through internal planning processes.

The Health Insurance coverage plays a vital role for those students who are not covered by their parents or their own health coverage – the latter group can opt out of the Algoma Health coverage. Before we had a good health plan for students, there were many requests for additional assistance for students who had medical needs for themselves or for their dependents. We are currently working with those students who have not opted out to see if our coverage meets their needs, and we are also again investigating alternative coverage that might be less expensive.

International Tuition Fee Background

Algoma University ("'AU") has raised international tuition fees by a flat 4% each year since 2005-06. Based on our survey of international fees charged by Ontario universities, for the academic year 08-09 of the 19 Ontario universities, AU has the:

• 3<sup>rd</sup> lowest tuition fees, at \$11,326 – 87% of the Ontario average

Students coming to Algoma from abroad consistently ask about scholarships. Without a scholarship program to recognize and acknowledge excellence, we are much less competitive on the recruitment front (all other Ontario universities run a scholarship program for international students). We are therefore proposing a substantial 10% increase to the international fees for all first-time registrants, with most of the increase allocated to a scholarship program to recognize excellence (as well as a small bursary allocation for unexpected needs during the academic year). For all continuing international students, we propose the same increase of 4% as for domestic students.

Our SPELL program (English-as-a-second-language) is run on a break-even or profit basis. Every year, several SPELL graduates return to Algoma U for degree programs. SPELL also welcomes groups of students from countries such as Mexico and Japan; their presence enriches campus life. We propose an increase of 3.6% so that SPELL continues to meet the mandate of being a "cost recovery" program. Under this proposal, SPELL fees would rise from current \$2,800 to \$2,900 per term.

#### **Student Assistance**

The Ontario government has established Principles of Student Access in partnership with provincially-assisted universities. These principles state that:

- ✓ No qualified Ontario student should be prevented from attending Ontario's public colleges and universities due to lack of financial support programs, and;
- ✓ Students in need should have access to the resources they need for their tuition, books, compulsory fees, equipment, and supplies.

The Student Access Guarantee (SAG) program guarantees students that their OSAP assistance will cover the full cost of tuition and books. If OSAP does not meet that full cost, then SAG automatically tops up their allocation. Algoma University, as all Ontario universities, is responsible for the SAG component, and meets this responsibility largely through tuition fee increases.

The following excerpt from the Ministry's SAG guidelines explains the Ministry's and universities' commitments to student aid:

"The Province is participating in the student access guarantee initiative by providing improved financial aid to Ontario students, through the Ontario Student Assistance Program (OSAP). It has made major improvements and new investments in government student aid each year since 2003-04 to enable OSAP to better support access. The number of students receiving aid and the level of support provided both have increased substantially.

These improvements will continue as the student access guarantee initiative continues to be developed. Over a five-year period from 2004-05 to 2009-10, the Ministry's annual student aid

expenditure will double. OSAP improvements to date include new access grants for first-year and second-year students from lower and lower-middle-income families, reductions to parental contributions, updated loan limits, and updated book and supply allowances.

Universities and colleges deliver institutional financial aid that supplements government aid in a variety of ways. Institutions' required Tuition Set-Aside fund expenditures for need-based student aid totalled about \$188 million in 2005-06. The amount of these required expenditures will increase to reflect enrolment growth. In addition, the Ministry has been supporting institutions' development of further financial resources for needs-based aid. In 2007-08, endowments raised with matching through the Ontario Trust for Student Support (OTSS) and Ontario Student Opportunity Trust Fund (OSOTF) programs will generate about \$59 million in funds available for institutional student aid.

To participate in the student access guarantee, institutions are expected to draw on these resources, and on other institutional resources, as needed.

The tuition framework does not mandate a specific set aside from additional tuition revenue levied on each student under the framework. This follows the institutional recommendation to provide flexibility. It does, however, require institutions to direct additional resources for student aid, as required, to ensure that the terms of the student access guarantee are met. The student access guarantee recognizes the relationship between institutional decisions to increase tuition, the student call on OSAP, and the student need for additional resources above OSAP."

As part of Algoma's participation is the SAG program, we provide a "Multi-Year Accountability" plan to the Ministry, with our commitment to ensure that all students have full access to SAG. Tuition fee increases will assist Algoma in ensuring that we have adequate funds available to meet these student aid commitments.

#### **Recommendations:**

- 1. MOTION: That undergraduate domestic student fees increase by 4%
- 2. MOTION: That international undergraduate student fees for all continuing students increase by 4%.
- 3. MOTION: That international undergraduate student fees for all first-time registrants increase by 10%.
- 4. MOTION: That SPELL (English as a 2<sup>nd</sup> language) tuition fees increase by 3.6%
- 5. MOTION: That the Accelerated second degree program fees increase by 4% for domestic students and by 10% for international students

The accelerated second degree program is run in Brampton. Students must have a first undergraduate degree to enter the program, then they can earn a second undergraduate degree in Computer Science over a 12 month period. Since this is a compressed program (one and a half years of credits delivered over 12 months), its fee structure is somewhat different from on-campus fees. We are proposing similar increases to fees for the Accelerated program as for on-campus.
